It was a pleasure speaking with you today. Should you wish to write to Dr. Susan Blackmore, her address is: University of the West of England, Bristol BS16 2JP, England. As I mentioned during our conversation, articles by Dr. Blackmore (as well as many other articles by many other authors, which your librarian may be able to obtain for you) have appeared in the *Skeptical Inquirer*. Dr. Blackmore has also published articles in other periodicals and journals, and has written several books.


Dr. Ray Hyman's classic article, "Cold Reading: How to Convince Strangers That You Know All About Them," appeared in *Skeptical Inquirer* in 1977, long before *S.I.* was indexed in the *Readers Guide to Periodical Literature*. The article is 20 pages long, but requires only 10 photocopies (2 pages per copy), which I could provide for you at 10¢ per copy.

An important series of experiments in parapsychology by Dr. Robert Jahn at Princeton University was reviewed very unfavorably in the *Journal of Parapsychology*, Vol. 56, June 1992. Interestingly, this critical review was written by three investigators who believe in the reality of psychic phenomena, as opposed to skeptics such as myself. A summary of this review can be found on pp. 357-58 of *Skeptical Inquirer*, Vol. 17, No. 4, Summer 1993.

Noreen Renier, an Orlando "psychic detective," has appeared on many TV shows. I wrote a skeptical chapter about her for the book *Psychic Sleuths: ESP and Sensational Cases* (Prometheus Books, Buffalo, 1994). The chapter is 26 pages long (13 photocopies).
